SVRDC Requirements

Please understand that by auditioning, you are **committing to SVRDC** and the other dancers. If you cannot commit 100%, we ask that you consider not auditioning for this season. **Rehearsals will need to take priority over school plays, cheerleading, after-school activities, choral concerts, etc.** All parts, for each production, are cast as final regardless of race, religion, or creed. Parts will be assigned by a panel of independent judges and are based on the dancers abilities. All dancers must have at least ONE year of dance experience, and be 7 years old by September 1, 2011.

- 1) Auditioning does not mean you are automatically cast in the production. You will be notified by mail if you are cast. Parts awarded to dancers are to be accepted in full, or declined in full. SVRDC does not negotiate once parts are distributed.
- 2) Audition fee (\$25.00) is non-refundable and is not a part of participation fees or the Company Member fees. Audition fee and application are due prior to the start of scheduled auditions.
- 3) Seasonal Fundraising, Fees, and Volunteer Obligations to SVRDC.
 - a. All families are required to participate in fundraising for the 2012 season to be completed no later than December 31st. In lieu of fundraising, you may opt to pay a buy-out fee. If you do not complete your fundraising requirements, you will not be able to audition for the next season. Please reference www.svrdc.org for exact requirement amount and dates due.
 - b. Required Volunteer Hours are 7 hours per dancer, or 10 hours per family per production. If you do not complete your hours in full by December 31st, you will be charged \$75.00. This fee is due prior to the next season's audition date. Volunteer hours are not transferrable to other families – everyone is needed to help assist and promote each production.
 - c. Participation fees must be paid in full, no later than the second rehearsal of each production they are cast in. Exact fees are based on the number of parts assigned by production, will be listed on the casting letter. The fees are as follows:

- 4) All questions, comments, absences, etc. must be directed to thesvrdc@yahoo.com and will be addressed by a member of the Board of Directors.
- 5) Attendance is **mandatory** for all tech and dress rehearsals. Dancers arriving late or leaving early receive 1/3 absence.
- 6) It is the dancer's responsibility to remain current on communication; please check the company bulletin board, web site, Facebook, Twitter, and email regularly.
- 7) Company I Dancers, Company II Dancers and Non-Company Dancers are required to take regular classes, including summer classes. Please refer to the 2012 Season Requirements for details. Written proof of classes not taken at PDT must be submitted and approved by SVRDC.
- 8) Dancers and their families must demonstrate positive behavior towards their fellow dancers and families, as well as board members and artistic staff; other behaviors may jeopardize membership and participation. Please note the SVRDC Core Values - *Respect of Others, Do the Right Thing, Strive for Excellence, and Give Back to the Community.*
- 9) Company I and II Dancers are required to sign all of their company forms and pay membership fees no later than January 14, 2012. Company I and II Dancers will be required to re-audition in the summer. There will not be a form or fee for this second audition. Date and time TBD.
- 10) Non-Company members will be given their forms prior to the first rehearsal of each production they are cast in, and will be required to sign and return them along with their assigned participation fee, no later than the second rehearsal of each production they are cast in.
