- 2012 Season Auditions
 - January 7th, 12-1:30pm for pointe; 2-3 for non-pointe; completed audition form with non-refundable \$25 audition fee due on or before January 7th
 - Audition fee is non-refundable and will not count towards participation fee (Please note that Nutcracker Angel-only and Party Scene Adults will audition in September 2012. Exact dates will be announced on our website in June 2012.)
 - You can specify which shows you will be auditioning for on the application form.
 - Must be at least 7 years old by September 1, 2011 to audition.
 - Must have a minimum of 1 year dance experience.
 - If taking classes other than at PDT, must provide proof of classes at time of audition. (type, date, instructor).

2012 Season Requirements:

1. Fundraising Requirements

Company Members:

- Buy-out \$125 if paid by 2nd rehearsal of your first production (increases to \$150 after that date) or need to sell \$300 by December 31st
 - If you do not meet this requirement by December 31st, you will need to pay difference prior to 2013 season's audition in January.

Graduating Seniors – Company Members:

- Buy-out \$40 if paid by 2nd rehearsal of your first production (increases to \$50 after that date) or need to sell \$100 by April 14th
 - If you do not meet this requirement by April 14th you will not be allowed to dance in Jazzerella!

Non-Company Dancers:

- **Jazzerella** – \$33 buyout due by 2nd rehearsal or need to sell \$100
- **Tales from the Crypt** – \$33 buyout due by 2nd rehearsal or need to sell \$100
- **Nutcracker** - \$50 buyout due by 2nd rehearsal or need to sell \$100
- If you do not meet these requirements by the final performance of each production, you will need to pay difference or you will not be eligible to audition for the 2013 season in January.

We welcome your ideas!

- If you or your family would like to take the lead for a fundraising event, contact the Board of Directors with details. If your suggestion is approved, your fundraising fee will be waived as long as monies obtained from fundraiser are greater than or equal to \$75.

2. Volunteer Hours Requirement

ALL Dancers:

- Must complete 7 hours per dancer (or 10 hours per family) PER PERFORMANCE by performance date of that production or pay buy-out fee of \$75 for the season.
- Hours need to be completed or buy-out fee paid prior to 2013 season's audition in January.
 - Volunteer hours can be done by dancer or dancer's family members.

3. Dancer Forms

- Company Member/Dancer Contract, Season Release, Photo Release and Emergency Contact Information Form. Company Members information due January 14th. Non-Company Members will be given forms at their first production's orientation. Due back within one week.
- All forms can be found on SVRDC's website.

4. Non-Company Member Participation Fees

- Participation Fees for ALL Non-Company Dancers are non-refundable and will be due on the first day of rehearsal for that production. You will receive an email with your assigned parts and fee amount prior to the first rehearsal.

6. Other Specific Auditions

New dancers to area – mid-season Auditions

- New dancers to the area will be able to audition in June 2012 for selected parts in Tales from the Crypt and The Nutcracker. Please watch the website for exact date and time.
 - Audition application AND \$25 audition fee are due at time of audition.
 - All dancer forms and fees will be required once your part is confirmed.

Nutcracker Angel ONLY Auditions

- Those interested in auditioning for ONLY the part of an Angel in the Nutcracker must be at least 7 years old by September 1, 2012. Auditions will be held in September 2012. Exact date and time will be posted on the SVRDC's website in June 2012.
 - Audition application AND \$25 audition fee are due at time of audition.
 - Those selected to be Angels ONLY, will have your participation fee waived.
 - All dancer forms will be required once your part is confirmed.

Nutcracker Adults ONLY Auditions

- Those interested in auditioning to be an adult for Party Scene in the Nutcracker will audition in September 2012. Exact date and time will be posted on the SVRDC's website in June 2012.
 - Audition application AND \$25 audition fee are due at time of audition.
 - All dancer forms and fees will be required once your part is confirmed.
